- **FOR TURF AREAS:** Coverage 5 000 – 10 000 sq ft. Apply 5 lbs per 1000 sq. ft or 220 lbs per acre. A high rate of 10 lbs per 1000 sq ft or 450 lbs per acre may be used on established turf. **Apply to dry turf. Water in thoroughly.**

SOLU-CAL PEAK IRON if used at 220 lbs per acre will provide 0.2 lb of nitrogen, 0.3 lb of potassium and 0.6 lb of calcium and 0.25 lb of magnesium per 1000 sq ft with each application. It is ideal for all turf types.
